MINUTES OF A MEETING OF THE UNIVERSITY SENATE

- 1. Senator Spiggle officially called the regular meeting of the University Senate of May 3, 2004 to order at 4:05 p.m. in room 7, Bishop Center.
- 2. The minutes of the April 12, 2004 meeting of the University Senate were approved as written.
- 3. Report of the President

President Austin reported the budget passed both houses of the Connecticut Legislature. It is now awaiting the Governor's signature. Many elements of the budget are favorable to UConn. The funds to correct problems at the Law School Library we approved. President Austin wished Provost Petersen well in his new job as President of the University of Tennessee. We will conduct a national search for a new Provost. We will not utilize a search firm to locate qualified candidates – please contact President Austin if you know of qualified candidates. Senior Vice Provost Fred Maryanski will serve as the Interim Provost during this transition period. Commencement is this coming weekend – President Austin welcomes your participation.

Provost Peterson thanked members of the Senate for sustaining a shared governance environment and turning adversity into positive directions.

14. Senator Jeffers presented the Report of the Curricula & Courses Committee

- A. The committee recommends approval of the following new 100-level courses:
 - ENGL 1XX. Introduction to American Studies
 <u>Proposed catalog copy</u>: (Also offered as INTD 165.) First semester. Three Credits. Not open to
 students who have passed INTD 276. What is an American? A multi-disciplinary inquiry into
 American societies and cultures.
 - GEOL 103. Earth & Life Through Time (Lecture)
 <u>Proposed catalog copy</u>: Both semesters. Three credits. Three class periods. Not open to students
 enrolled in or having passed GEOL 105. For students who later complete GEOL 107 this course will
 be converted from a Group 8 Non-laboratory course to a Group 8 Laboratory course. History of
 planet Earth, emphasizing how rock, air, water, and life interact at different scales to produce the
 earth's crust, landforms, life systems, natural resources, catastrophes, and climatic regimes.
 Provides a scientific context for human-induced global change.
 - GEOL 105. Earth & Life Through Time (Lecture + Lab). <u>Proposed catalog copy</u>: Both semesters. Four credits. Three class periods and one three-hour lab. Not open to students enrolled in or having passed GEOL 103. History of planet Earth, emphasizing how rock, air, water, and life interact at different scales to produce the earth's crust, landforms, life systems, natural resources, catastrophes, and climatic regimes. Provides a scientific context for human-induced global change. Includes laboratory component (see GEOL 107).
 - GEOL 107. Earth & Life Through Time (Lab).
 <u>Proposed catalog copy</u>: Both semesters. One credit. One three-hour lab period. Prerequisite: GEOL 103. Not open to students enrolled in or having passed GEOL 105. Laboratory complement to GEOL 103. Provides an opportunity to work with specimens (minerals, fossils, rocks), terrain images, maps, physical models, and simulation experiments. Includes two local field trips.
 - GEOL 109. Earth & Life Through Time (Discussion).
 <u>Proposed catalog copy</u>: Both semesters. One credit. One three-hour discussion period.
 Prerequisite: concurrent enrollment in GEOL 103, 105, or 107 or consent of instructor. May be repeated for credit with consent of instructor. Faculty-taught, weekly discussions to enhance GEOL 103 and GEOL 105. Emphasis and approach will vary, but all sections will track the lecture syllabus.
 - GEOL 113. Earth & Life Through Time (Field Trips). <u>Proposed catalog copy</u>: Both semesters. One credit. Hours to be arranged. Prerequisite: concurrent enrollment in GEOL 103, 105, or 107 or consent of instructor. May be repeated for credit with consent of instructor. Two or more Faculty-led weekend field trips to nearby sites of interest, designed to enhance GEOL 103 and GEOL 105.

The motion carried.

B. The committee recommends adding the following 100-level courses to group 8 Science and Technology of the current general education courses:

- GEOL 103. Earth & Life Through Time (Lecture)
- GEOL 105. Earth & Life Through Time (Lecture + Lab). This course is to be part of the group 8 laboratory courses.

- 15. Senator Zirakzadeh presented the Report of the Scholastic Standards Committee

- Motion: The Scholastic Standards Committee moves that the University Senate establish the following two guidelines for department heads when scheduling either three-credit or fourcredit courses for intensive (less than four-week) sessions:
 - 1. The assignment of instructors—regardless if adjunct or full-time—for courses during the intensive sessions who have not taught the course during a regular 14-week school term is inappropriate.
 - 2. Department heads should approve courses for intensive sessions only after determining that the proposed course will be fully equivalent in coverage, depth, and rigor to a course taught during a regular 14-week session. Certain three-credit and four-credit courses are not recommended for intensive sessions: courses that require hours in the laboratory or studio, or skill courses, such as writing "W" courses.

The motion carried.

- Motion: The Scholastic Standards Committee moves that Section II.E.10 of the Senate By-Laws be revised to read (new language is underlined):
 - 10. Appeals of Assigned Course Grades

A student who believes that an error in grading has occurred may request a review by the instructor of record <u>within six months of the course grade having been posted</u>. If the instructor of record cannot be contacted, the student <u>should contact the Department Head</u>. If the instructor agrees that a change is justified, the instructor will initiate the grade change (according to the procedure in the previous section of these By-Laws).

The motion carried.

Senator Thorson proposed the Senate substitute the word "must" for the word "may" amendment.

The motion to amend was seconded and carried.

Senator Hiskes proposed substituting the phrase "and wishes to request a review" for "request a review."

The motion to amend was seconded and carried.

Senator Sydney proposed adding the phrase: "Individual schools and colleges may have more stringent requirements than the six month requirement of this by-law."

The motion to amend was seconded and carried.

The amended motion to "add a six month deadline for initiating a grade appeal" carried. This change will go into effect Fall 2004.
