MINUTES OF A MEETING OF THE UNIVERSITY SENATE
September 13, 2004

1. President Austin officially called the regular meeting of the University Senate of September 13, 2004 to order at 4:04 p.m. in Room 7 of the Bishop Center.
2. Election of Moderator – Senator von Munkwitz-Smith nominated Senator Susan Spiggle as Moderator of the University Senate. Senator Zirakzadeh seconded the nomination. The Senate approved without dissent.
3. Election of Secretary – Senator Zirakzadeh nominated Mr. Kim Chambers. Senator Rodin seconded the nomination. The Senate approved without dissent.
4. Senator Spiggle assumed her duties as Moderator of the Senate. She asked the Senators and support staff to introduce themselves, including their departmental affiliation.
5. Approval of Minutes

Senator Spiggle presented the Minutes of the regular meeting of May 3, 2004 for review.

The minutes were approved without modification.

6. Report of the President

President Austin welcomed Senators to the beginning of the academic year. He summarized recent developments:

- a. The student academic profile is gratifying. Approximately 20,000 applicants. Approximately 100 new valedictorians and salutatorians have been admitted. There is a 9-point increase in SATs over last year.
- b. There are plans to expand faculty jobs over the next 5 years by hiring 150 new faculty.
- c. President Austin reported on his meeting with Governor Rell who supports the 21st Century UConn monies
- d. President Austin informed the Senate that the Research Institute report had been submitted for consideration.
- e. There was a summer carbon monoxide scare in two Hilltop Apartments. The University quickly disconnected the air conditioners in these apartments and is seeking an architectural solution.
- f. There was graduate student from Kenya with tuberculosis symptoms. Health professionals are responding appropriately.

President Austin addressed questions from the Senate including the North Eagleville parking situation.

The Registrar's office may choose to attach temporary skill code designations to courses or modify catalog copy to indicate their role in the old system, for the benefit of students selecting courses to fulfill the previous general education requirements.
