

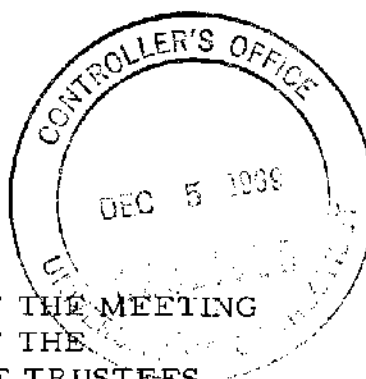

MINUTES OF THE MEETING
OF THE
BOARD OF TRUSTEES

THE UNIVERSITY OF CONNECTICUT

Held at the School of Law

November 19, 1969

The meeting was called to order at 10:10 a. m. by Chairman John J. Budds. Board members present were: Mrs. Bailey, Messrs. Bishop, Budds, Gill, Holt, Marcus, Maxcy, McCormick, Nielsen, Tasker and Waller.

Also present were: President Babbidge, Mr. Gant, Provost and Academic Vice President and Mr. Evans, Vice President for Financial Affairs.

All actions taken at the meeting were by unanimous vote of the Trustees except as noted in Section 15, page 4224.

1. Dean Howard Sacks in welcoming the Board to the School of Law commented briefly on recent progress and activities at the School. Dean Sacks also prompted further comments from David Marr, the student editor of the University of Connecticut LAW REVIEW and Assistant Professor Joseph Harbaugh, faculty coordinator of "the legal clinic" a new intern program.
2. THE BOARD VOTED to approve the minutes of the meetings of September 17, 1969 and October 12, 1969.
3. Acting on Mr. Holt's recommendation as Chairman of the Finance Committee, THE BOARD VOTED to approve the following contracts and agreements and to authorize the President, Vice President for Financial Affairs, or Assistant Vice Presidents to sign the necessary documents on behalf of the University:

STORRS CAMPUS

- (1) Agreement with the Hamden-New Haven Cooperative Education Center.
Amount: Approximately \$1,400.
Effective Dates: September 22, 1969 to September 21, 1970.
Purpose: To provide reimbursement for utility and maintenance expenses for the University's Urban Education Program at the New Haven-Hamden Teaching Center. This activity is sponsored by the School of Education under the Educational Professional Development Act grant and provides a professional semester in an inner-city environment for our students who are interested in this type of teaching.
- (2) Agreement with James Lenehen.
Amount: \$4,950.
Effective Dates: October 1, 1969 to August 31, 1970.
Purpose: A grant providing for funding a Computer Programmer has been received from the College Entrance Examination Board by the Counseling and Testing Center in the University's Division of Student Personnel. The Contractor will write all computer programs as required in this project, consult with the project director concerning design specifications, programming progress and problems, provide program debugging, documentation, assistance in form design and preparation of MTA user's manual. This work will be under the direction of Mr. Richard O. Goodwillie.
- (3) Agreement with Dr. Burton Blatt, Director Division of Special Education and Rehabilitation and Professor of Special Education at Syracuse University.
Amount: \$8,000.
Effective Dates: September 1, 1969 to August 31, 1970.
Purpose: To evaluate project entitled "Preparation and Reorientation of Education Personnel Toward Handicapped Children in Disadvantaged Area" by (1) Conducting a minimum of three site visits including interviewing staff and participants in the program; (2) Administering selected attitude and component scales to participants; (3) Analyze impact on Arsenal School in Hartford and (4) Provide specific procedures and tests for evaluating the University's extern and field training programs for use during two institutes to be conducted by the University. This work is for the Educational Psychology Department under the direction of Mr. John Cawley. The costs of this project will be paid by a research grant.
- (4) Agreement with Mrs. Ruth Arendt, Professional Skating Instructor
Amount: \$4,000.
Effective Dates: November 1, 1969 to March 31, 1970.
Purpose: To (1) instruct Physical Education Classes, Saturday Morning School and Student Figure Skating and Adult Class, (2) Supervise Moonlight Mixer, (3) Consult and assist in the Ice Rink Special Events for the University's Athletic Department.

- (5) Agreement with the American Academy of Arts and Sciences
Amount: \$5,000.
Effective Dates: September 11 to September 15, 1969.
Purpose: Partial funding of a Conference on History and Philosophy of Science to be held at the Minnesota Center for Philosophy of Sciences. Funds will come from a grant from the Council for Philosophical Studies under the direction of Mr. Jerome Shaffer of the University's Philosophy Department.
- (6) Agreement with Princeton University
Amount: \$1,800.
Effective Dates: August 24 to August 26, 1969.
Purpose: Under the provisions of a grant from the Council for Philosophical Studies to the University's Philosophy Department, funds are provided for an Interdisciplinary Conference of the Semantics of Natural Language held at the Center for Advanced Study in the Behavioral Sciences, Palo Alto, California. The expenses of the participants will be paid by Princeton and the University will pay Princeton \$1,800 as our share. This grant is under the direction of Mr. Jerone Shaffer.
- (7) Agreement with the Institut Für Theoretische Physikalische Chemie, Universität Stuttgart of West Germany.
Amount: \$500
Effective Dates: November 1, 1969 through November 1, 1970
Purpose: Dr. Carl W. David of the University's Chemistry Department is conducting a study entitled "The Problem of Generating Unlabelled Star Graphs" under which he will require the services of the Contractor's Darmstadt Computer for approximately 2-1/2 hours. The costs for the use of this computer will be paid from funds available in the Research Foundation grant awarded for this study.
- (8) Agreement with Dr. Richard J. Weiss of Materials Research Labs., Watertown, Massachusetts
Amount: \$1,000
Effective Dates: September 10, 1969 to May 31, 1970
Purpose: To act as a "Reviewer" for the purpose of reading and revising certain portions of a book titled "Physics of X-Ray Diffraction" under the instructions of Dr. L. V. Azaroff of the University's Institute of Materials Science. The cost of the work is to be paid out of research funds.
- (9) Agreement with Dr. E. F. Bertaut of 38-Grenoble, Gare, France
Amount: \$2,000
Effective Dates: September 10, 1969 to May 31, 1970
Purpose: To act as a "Reviewer" for the purpose of reading and revising certain portions of a book titled "Physics of X-Ray Diffraction" under the instructions of Dr. L. V. Azaroff of the University's Institute of Materials Science. The cost of the work is to be paid out of research funds.

- (10) Agreement with Professor R. A. Young of Georgia Institute of Technology, Atlanta, Georgia.
Amount: \$3,000 plus 1% of gross royalties derived from publication.
Effective Dates: November 10, 1968 to April 1970.
Purpose: To work as a "Co-author" in contributing a chapter on the subject of "Intensity Measurements" to a book titled "X-Rays, Their Generation, Consumption, and Diffraction" to be edited by Dr. L. Purpose: To work as a "Co-author" in contributing a chapter on the subject of "Scattering by Aggregates" to a book titled "X-Rays, Their Generation, Consumption, and Diffraction" to be edited by Dr. L. V. Azaroff of the University's Institute of Materials Science. Funds for this will be paid from Research funds.
- (14) Agreement with Professor Nario Kato of Faculty of Engineering, Nagoya University, in Nagoya, Japan
Amount: \$3,000 plus 1% of gross royalties derived from publication.
Effective Dates: November 10, 1968 to April 1970
Purpose: To work as a "Co-author" in contributing a chapter on the subject of "Diffraction by Crystals" to a book titled "X-Rays, Their Generation, Consumption, and Diffraction" to be edited by Dr. L. V. Azaroff of the University's Institute of Materials Science. Funds for this will be paid from Research funds.

- (15) Amendment to the agreement with Office du Tourisme Universitaire et Scolaire for the Department of Romance and Classical Languages.
Amount: \$9,115. (no change)
Effective Dates: September 18, 1969 to October 29, 1969 (no change)
Purpose: For breakfast, lodging, excursions, and orientation program exclusive of examination fees, for 36 students in the Junior Year in France Program.
- (16) Amendment to the agreement with Faculte des Lettres et Sciences Humaines, University of Rouen, Mons. L. Harmand for the Department of Romance and Classical Languages.
Amount: \$15,225 (change from \$13,380)
Effective Dates: November 1, 1969 to June 10, 1970 (no change)
Purpose: To provide office space, use of part-time secretary, course costs, telephone, registration and examination fees for students in the Junior Year in France Program.
- (17) Agreement with Robert S. McMillan Associates, New Haven, Connecticut.
Amount: \$25,000
Effective Dates: September 1, 1969 through January 1, 1970
Purpose: To provide consulting services for assistance in the preparation and review of program documents, the siting of buildings in relation to overall planning guidelines, and to offer general consultation on traffic, parking, and other problems. The cost of the work is to be paid from funds allotted to the University by the Commission for Higher Education.
- (18) Renewal lease with Leroy Pittman, Jr. of Hartford
Amount: \$3,840 per year
Effective Dates: September 16, 1969 to September 15, 1970
Purpose: To rent two apartments located at 280 Enfield Street in Hartford for use by the Urban Semester Program. This program is under the direction of Dr. Michael Wogan.
- (19) Renewal lease with Philemon A. Warzocha of Storrs
Amount: \$7,123.44
Effective Dates: December 1, 1969 to November 30, 1970
Purpose: To rent 1,583 square feet of office space on Dog Lane in Storrs to be used by the offices of the Dining Hall Administration.
- (20) Renewal lease with The Mansfield Investment Company of Mansfield
Amount: \$8,976
Effective Dates: December 19, 1969 to December 18, 1970
Purpose: To rent 1,825 square feet of office space in Mansfield Professional Park in Mansfield which is being used by the NERAC Project in the School of Business Administration.

- (21) Lease with FCH Services, Inc., James Darcy Project Manager of Bridgeport, managing agents for the Housing Division of Department of Community Affairs of the State of Connecticut.
Amount: \$75 per month
Effective Dates: August 1, 1969
Purpose: To rent Apt. 105 at Beardsley Terrace in Bridgeport to be used for the Agricultural Extension Expanded Nutrition Education Program. This apartment is located in a housing project containing over 1,000 low-income families and will be used for office and educational purposes. The cost will be paid from funds available in the University's Special Federal Nutrition Education Project.

HEALTH CENTER

- (1) Agreement with Mr. John E. Flynn and Mr. George R. Holeman
Amount: Not to exceed \$6,000 per year
Effective Dates: December 1, 1969 to November 30, 1970
Purpose: To provide radiation safety consulting service for the Health Center.
- (2) Agreement with Yale University
Amount: No cost to the University
Effective Dates: August 1, 1969 through December 31, 1969
Purpose: To provide Connecticut Regional Medical Program short courses, seminars, and lectures for dentists and supporting personnel in the state; and through long-range planning to provide for the establishment of several continuing education centers in the state, each organized around the activities of community hospital comprehensive dental care programs.
- (3) Agreement with Ernst & Ernst
Amount: Not to exceed \$9,000
Effective Dates: October 1, 1969 through September 30, 1970
Purpose: To provide accounting and auditing services at McCook Hospital, particularly relevant to certification of financial operations as required by the Connecticut Hospital Association annually for all general hospitals in the state.
4. Mr. Holt, Chairman of the Finance Committee, in presenting a report on the University's endowment fund as of September 30, 1969, recommended the sale of securities totaling \$170,023, and purchases amounting to \$170,500. THE BOARD VOTED to approve the recommendation of the Finance Committee.

5. Acting upon the recommendation of Provost Gant, THE BOARD VOTED to approve a revision of graduate offerings in the fields of Biobehavioral Sciences making it possible for students to obtain a master's program in the broad area of Biobehavioral Sciences and doctoral programs in the following areas:
 - Behavioral Genetics
 - Biological Anthropology
 - Developmental Psychobiology
 - Endocrinology
 - Human Genetics
 - Neuropsychology
6. Provost Gant informed the Board that the National Science Foundation has authorized the University to exceed the previous expenditure limitation of \$700,000 by five percent if necessary to support Foundation sponsored activities at an effective level.
7. The Provost called the Board's attention to a letter of appreciation from Dr. Edward H. Kirschbaum upon learning that the new library at the Waterbury Branch had been named in his honor.
8. Provost Gant reported that the Board of Directors of the American Boards of Examiners in Speech Pathology and Audiology has accredited the University's education and training program in Audiology. The Provost observed that very few programs in the country are accredited and the University's program is the only accredited program in New England.
9. President Babbidge commented briefly on the success of the Junior Year Abroad program in France at the University of Rouen. The President indicated that the educational and residential costs are not too different from those of students on the campus at Storrs.
10. In referring to the draft statement, "Goals for Higher Education in Connecticut," Mr. Bishop urged the Trustees to forward comments to his attention since the goal statement will be discussed at the next meeting of the Commission for Higher Education.
11. THE BOARD VOTED to authorize the Finance Committee to act on the matter of increasing student activities fees when the student organizations involved have agreed upon their financial needs. The fee changes will be reported to the Board at their December meeting.
12. President Babbidge informed the Board that the faculty committee which has previously reviewed proposals to the U. S. Public Health Service for research involving humans as subjects will also review all research proposals involving research on humans as subjects. The President also reported the creation of a similar committee at the Health Center.

13. President Babbidge called the Board's attention to the following policy conclusions recently announced by the Housing Policy Committee:
- (1) The University should adopt a forthright policy of prohibiting practices by which residents of a given dormitory might select fellow residents on the basis of personal acceptability.
 - (2) In view of the fact that many students begin college with an imperfect appreciation of important educational and social matters, we feel most strongly that housing policies should encourage in students a sensitive awareness of the varied contributions of all their fellow students. Accordingly we believe that the University's housing policies should help ensure that young people who come to the campus with prematurely fixed attitudes do not fall into housing arrangements that simply reinforce those attitudes.
 - (3) Recognizing the necessity of communication between people of different experiences as well as the legitimate desires of most people to feel at ease within their surroundings, we endorse the constitution of certain ethnically heterogeneous housing arrangements expressly set up so as to alleviate feelings of discomfort among minority group students within such arrangements.

After considerable discussion THE BOARD VOTED to record their support of the committees initial policy conclusions. The Board also voiced their interest in receiving further details relative to specific implementation of the rules and policies.

14. Chairman Budds, on behalf of the Board presented a pen-desk set to Provost Gant as a token of the Trustees appreciation for his outstanding performance in the role of Acting President during the President's absence from the University.
15. After an extended discussion of intervisitation in residence halls, THE BOARD VOTED to approve the following resolution:
- (a) The Board of Trustees reaffirms its responsibility and authority to provide for the governance, supervision and administration of the University residence halls in order to achieve the furtherance of the halls' stated purposes, and to promote the safety of the students who reside therein.
 - (b) The Board has heard a report from the President, and concludes that the experimental intervisitation policies in force for several semesters have demonstrated considerable merit. This experience suggests that the great majority of students have, when

afforded the opportunity, demonstrated responsible behavior in visiting among the residence halls. The Board feels an atmosphere of liberal social intervisitation provides a desirable feature of dormitory living on a coeducational campus. The Board is accordingly prepared to extend throughout the week the practice of social intervisitation hitherto permitted only on weekends.

- (c) The Board acknowledges a broad variety of opinion among students concerning the appropriate hours of visitation. Therefore students in any residence unit shall accordingly vote to establish by a 2/3 vote visiting hours which fall between noon and midnight. Extension of visitation beyond these hours will be permitted only during that period when the unit is conventionally open, and any such extension must receive the approval of at least three-fourths of the unit's residents. The Division of Student Personnel shall administer the balloting for these purposes, and otherwise ensure that the rights of all residents are respected. Units sharing common facilities, such as the high-rise halls, must for these purposes establish the agreement of the appropriate fraction of the building's total population. Extended policies will take effect when acknowledged by the Division of Student Personnel.
- (d) The Board recognizes further the special requirements of security in women's residences. Any extension of visitation policies beyond the dinner hour in such units must therefore be accompanied by security provisions acceptable to the Division of Student Personnel.
- (e) The Board reminds students of the existence of statutory provisions related to social relationships and behavior, which must of course be observed.
- (f) A concern for public safety and personal security prompts the Board to affirm that any persons discovered in violation of the policies established as described herein may be subject to institutional penalties.

Mr. Nielsen abstained from voting on this issue and also withdrew his vote of approval of the Minutes of the Meeting of October 12, 1969 requesting his abstention on that vote also be made a matter of record. Mr. Nielsen stated further that he will abstain from voting on any rules governing student conduct until he has been assured by the Administration that the rules will be strictly enforced.

- 18. On the recommendation of Provost Gant THE BOARD VOTED to approve new stipends for graduate assistants for the 1970-71 academic year of \$3105, \$3375, and \$3975 for nine months of service. Their presentations called for additional courses on the Black experience, new budgetary support for the Black Studies Program, additional Black faculty and staff members, added space and funds for the Afro-American Cultural Center, and more elements related to the Black experience in such fields as music, political science and history.
- Mr. Budds thanked the students for their frank presentation and reaffirmed the Board's commitment to giving highest priority to promoting racial respect.


