MINUTES OF THE MEETING
OF THE
BOARD OF TRUSTEES
THE UNIVERSITY OF CONNECTICUT
Held at Storrs September 16, 1970

The meeting was called to order at 10:15 a.m. by Chairman John J. Budds.

Board members present were: Mrs. Jones, Messrs. Benton, Budds, Gill, Holt, Marcus, McCormick, Nielsen, Sanders and Tasker.

Also present were: President Babbidge, Provost Gant and Mr. Evans, Vice President for Financial Affairs.

All actions taken at the meeting were by unanimous vote of the Trustees present.

1. Chairman Budds appointed Mr. Holt to serve as Secretary pro tem in the absence of Mr. Bishop.
2. THE BOARD VOTED to approve the minutes of the meetings of July 15, 1970 and July 28, 1970.
3. Upon learning of the recent hospitalization of President Emeritus Albert N. Jorgensen, the Board asked President Babbidge to convey to Dr. Jorgensen its best wishes for a speedy recovery.
4. Acting on the recommendation of the newly appointed Chairman of the Finance Committee, THE BOARD VOTED to approve the following contracts and agreements and authorized the President, the Provost, the Vice President for Financial Affairs, or Assistant Vice Presidents to sign the necessary documents on behalf of the University.

STORRS CAMPUS

- (1) Agreement with the Center for the Environment of Man, Inc., of Hartford, Connecticut.
Amount: \$20,900
Effective Dates: June 1, 1970 to July 6, 1970
Purpose: The Center for the Environment of Man will provide seven consultants for the University's conference on "Environmental Studies" for the purpose of developing agenda and participation. The University will pay the Center from proceeds received from NSF Grant No. G4-3853, Dr. Hugh Clark, principal investigator.
- (2) Agreement with the State of Connecticut Water Resources Commission of the Department of Agriculture and Natural Resources.
Amount: \$10,500 (to University)
Effective Dates: Upon approval by the Commissioner of Finance and Control to September 15, 1971.
Purpose: The University's Marine Research Laboratory will conduct a study of the waters in Munford and Palmer Coves (Groton, Conn.) for biological observations. This project will be conducted by John Buck.
- (3) Agreement with Education and Training Consultants Company of Los Angeles, California.
Amount: \$2,623
Effective Dates: August 10, 1970 to September 15, 1970
Purpose: To provide the services of Dr. Leonard C. Silvern for the preparation, conducting, and evaluation of a five-day conference on "Designing Education and Training Systems in Guidance" during the period August 10 to 14, 1970 at Groton, Connecticut. This is sub-contracted from the University's project funded by the State Department of Education and will be under the direction of Elizabeth Roper of the Continuing Education Division.
- (4) Agreement with Old Sturbridge Village, Sturbridge, Massachusetts
Amount: \$12,000
Effective Dates: September 1, 1970 to August 31, 1971
Purpose: To provide the services of Dr. Barnes Reznik as coordinator and part-time instructional staff for an eleven-month Master's Program in historical museum and/or historical agency work. This is sub-contracted from the University's project funded by the National Endowment of the Humanities (0-330-0208-114), under the direction of Dr. Albert VanDusen of the History Department.

- (5) Agreement with the Commonwealth of Pennsylvania, Department of Education, PRIMES, Harrisburg, Pennsylvania
Amount: \$600
Effective Dates: September 1, 1970 to April 30, 1971
Purpose: To provide Computer Indexes of 24 basic elementary school mathematics textbooks, authority lists, and University Department of Educational Psychology staff training. This is funded by the University's U. S. Office of Education Grant No. OEG-0-70-2250 (607) "Arithmetic Project" (5. 171-0401-024), under the direction of John Cawley.
- (6) Agreement with the Department of Health, Office of Tuberculosis Control, Hospital Care and Rehabilitation, Hartford
Amount: \$11,055 (to University)
Effective Dates: September 1, 1970 to August 31, 1971
Purpose: The University will supply speech therapy services at Cedarcrest Hospital and Uncas-on-Thames Hospital. The services will be rendered by a faculty member, who will supervise, diagnose and evaluate the therapy program, and two graduate assistants from the Speech Department.
- (7) Agreement with Rath & Strong, Inc. of Boston, Massachusetts
Amount: \$1,674
Effective Dates: July 5, 1970 to July 17, 1970
Purpose: For professional services rendered by Dorian Shainin in connection with the U. S. Army Research and Development Symposium. These services include planning, making up material for and teaching at the Symposium. This work is under the direction of Mr. Albert Jeffers of the Division of Conferences and Institutes.
- (8) Agreement with Colorado College, Colorado Springs, Colorado
Amount: \$55,000
Effective Dates: June 20, 1970 to August 1, 1970
Purpose: To accommodate a Summer Institute in Greek Philosophy and Science sponsored by the University of Connecticut. Colorado College will provide room and board for approximately 150 people, a lecture hall and dining area, administrative, duplicating and library services. This program is under the direction of Jerome Shaffer of the University's Philosophy Department and will be funded by a grant award from the Carnegie Corporation titled "Council for Philosophical Studies."
- (9) Agreement with Office du Tourisme Universitaire et Scolaire, France
Amount: \$12,863
Effective Dates: September 16, 1970 to October 29, 1970

Purpose: To provide breakfast, lodging, excursions, fees and orientation program for 47 students participating in the Junior Year in France Program. This is conducted by the Romance and Classical Languages Department.

- (10) Amendment to agreement with the State of Connecticut Water Resources Commission.

Amount: \$1,800 (to University)

Effective Dates: September 17, 1969 to December 31, 1970
(extended from June 30, 1970)

Purpose: To conduct an engineering study to determine the most suitable outfall sewer location for the discharge of effluent from the proposed combined New London-Waterford pollution abatement facility. This work is being conducted by the Civil Engineering Department.

- (11) Amendment to agreement with the U. S. Department of Labor, Washington, D. C. through the State of Connecticut Labor Department.

Amount: \$1,486,051 (to University) (increased from \$1,211,051)

Effective Dates: February 1, 1970 to September 30, 1972

Purpose: To provide additional funds for study of "The Impact of Extending Unemployment Insurance to Agriculture Workers in the Northeastern States" to now include the State of Texas. Texas A & M University will be the cooperating sub-contractor.

- (12) Sub-contract with Texas A & M University, College Station, Texas

Amount: \$250,000

Effective Dates: July 1, 1970 to September 30, 1972

Purpose: To conduct a study of "The Impact of Extending Unemployment Insurance to Agricultural Workers in the Northeastern States," as a cooperating University. This sub-contract is authorized under prime contract with the U. S. Labor Department through the State of Connecticut Labor Department and the study is now being extended to the State of Texas.

- (13) Amendment to agreement with the Department of Agriculture and Natural Resources

Amount: \$50,000 (to University) (increased from \$25,000)

Effective Dates: November 16, 1969 to October 1, 1971
(extended from January 1, 1971)

Purpose: To provide additional funds for study to delineate the periphery of areas that may be designated as Tidal and Estuarine Marshes. Such delineations will be made pursuant to the criteria established in Section 1, Public Act 695. This work will be performed by the Marine Research Laboratory under the direction of John S. Rankin, Jr.

- (14) Agreement with the New Haven Board of Education, New Haven
Amount: \$5,000
Effective Dates: July 1, 1970 to June 30, 1971
Purpose: To provide reimbursement for utility and maintenance expenses for the University's Urban Education Program. This continuing activity is sponsored by the School of Education under the Educational Professional Development act grant and provides a professional semester in an inner-city environment for our students who are interested in this type of teaching.
- (15) Renewal lease with Charles A. Day of Storrs
Amount: \$4,500 per year
Effective Dates: July 1, 1970 to June 30, 1972
Purpose: To extend for two years the lease for parking lot facilities on King Hill Road in Storrs.
- (16) Agreement with Kellner-Oshry Associates, Boston, Mass.
Amount: \$45,000
Effective Dates: September 1, 1970 to May 31, 1971
Purpose: The Board of Trustees has previously authorized the expenditure of \$45,000 for this purpose. They also authorized the President to proceed with contractual arrangements. The contract has been drawn and all contractual arrangements arrived at. Our attorney now feels that the Board must approve the effective dates of the contract and a description of its purpose as follows: For the development of programs designed to promote individual and organizational change in race relations at the University of Connecticut.

HEALTH CENTER

- (1) Agreement with the Hartford Seminary Foundation
Amount: Not to exceed \$30,000
Effective Dates: 1970-71 academic year
Purpose: To provide housing for a maximum of thirty medical and dental students in either single rooms or two-room suites at a cost of \$950 or \$1,000, respectively, for room and board. The Seminary will bill the University, which in turn will bill the individual students.
- (2) Agreement with St. Francis Hospital
Amount: No cost to the University
Effective Dates: July 1, 1970 through June 30, 1971
Purpose: To provide for the rotation of residents.

- (3) Agreement with New Britain General Hospital
Amount: No cost to the University
Effective Dates: July 1, 1970 through June 30, 1971
Purpose: To provide for the rotation of residents and an intern.
- (4) Agreement with Newington Children's Hospital
Amount: No cost to the University
Effective Dates: July 1, 1970 through June 30, 1971
Purpose: To provide for the rotation of a resident.
- (5) Agreement with Mt. Sinai Hospital
Amount: Not to exceed \$2000
Effective Dates: July 1, 1970 through June 30, 1971
Purpose: To provide for the services of a pediatric intern at McCook Hospital.
- (6) Agreement with Hartford Hospital
Amount: No cost to the University
Effective Dates: July 1, 1970 through June 30, 1971
Purpose: To provide for the rotation of interns and residents.
- (7) Agreement with the Connecticut Department of Transportation
Amount: \$1
Purpose: To donate to the Health Center a 3.10 acre parcel of land in Farmington, including residence, for a 25-year period.
- (8) Agreement with the Veterans Administration Hospital
Amount: No cost to the University
Effective Dates: September 1, 1970 through June 30, 1971
Purpose: To supply professional direction and supervision of the Laboratory Medicine Service at the Newington VA Hospital in return for sufficient funds to enable the Department of Laboratory Medicine to employ an additional full-time faculty member. The actual professional responsibilities will be divided approximately equally among all of the faculty members of the department.
- (9) Agreement with Rockville General Hospital, Rockville, Connecticut.
Amount: No cost to the University
Effective Dates: August 31, 1970 to June 30, 1971.
It is agreed that this relationship will be reviewed annually on or about June 1 by the Hospital and the University.

Purpose: The relationship between Rockville General Hospital and the University will be known as an allied agreement rather than the typical affiliation agreement. The objective of this relationship will be to promote good will, improved communication, develop programs in continuing education and provide for University employees to visit and work with the people in the community hospital. With respect to the development of joint graduate internships and residencies, such arrangements will be considered more specifically at a later date.

5. Provost Gant informed the Board that approximately 19,000 applications for admission were submitted this year reflecting an increase of 1,000 over last years total. In addition, about 2,500 out-of-state inquiring students were advised not to apply for admission in light of the excessive number of applications. The Provost also indicated that 4,400 new students would be registered this fall, with about 2,900 of them attending the main campus at Storrs.
6. Chairman Budds, in noting that the new branch on the Greater Hartford campus was open, suggested that the Board meet in Hartford next month. It was agreed that the meeting on October 21, 1970 would be held at the Hartford Branch.
7. President Babbidge, in commenting on federal grant monies made available under the Higher Education Facilities Act, called the Board's attention to the limited amount of funds available for grant awards this year. In veiw of this financial shortage the President recommended that the University of Connecticut refrain from applying for Title 1 grant money this year. THE BOARD VOTED to adopt the administration's recommendation.

10. Provost Gant informed the Board that the new residence halls at the Graduate Center are oversubscribed. The new complex, the Provost added, will house 440 graduate students.
11. Following a brief discussion of the Alumni Proposal relative to eligibility for an undergraduate degree, Provost Gant agreed to review the feasibility of a Law School - Liberal Arts and Sciences arrangement such as was previously available.
12. President Babbidge, in a progress report on the development of the Northeastern Research Center for Wildlife Diseases, at the University of Connecticut, indicated that the program has matured and research activities are underway.
13. President Babbidge called upon Mr. Moreland, Assistant to the President, for a report on the University's new weekly newspaper. Mr. Moreland indicated that the new publication, "The University of Connecticut Chronicle," will attempt to cover University policies and programs on the campus, the branches, and the professional schools. The paper will contain no editorials or advertising.
14. Provost Gant presented a recommendation from the Law School calling for a change in the academic calendar for evening students to permit them to complete their program of instruction in four years and three five-week summer sessions. The Provost stated that the part-time students will still complete the Law School's requirement of 86 semester hours. THE BOARD VOTED to approve the recommended change in the work of the Evening Division.
15. Senator Benton congratulated President Babbidge on the excellence of his statement last July before the General Assembly's Subcommittee on Higher Education. Because of the importance of President Babbidge's comments and the perceptiveness of his analysis, Senator Benton requested a re-distribution of the statement to all Trustees.
16. Mr. McCormick's motion to go into executive session, seconded by Mr. Gill, was approved unanimously. While in executive session, the Board took the following actions:
 - (A) THE BOARD VOTED to approve, for purposes of the State auditors, a formal list of actions already taken on matters of re-assignments, appointments and salary increases. The lists were authorized to be signed by the Secretary of the Board.

- (B) Chairman Budds called the Board's attention to recent concerns and criticisms relative to the handling of funds turned over to the Associated Student Government for the support of student governmental activities. After a lengthy discussion, it was agreed that President Babbidge would report on the matter at the October 21st Board meeting in accordance with the following:

The Board noted the concerns registered by many students with officials of the university and with the Board, related to the expenditure of student activity fee monies by the Student Senate. The President of the Associated Student Government met with the Board and acknowledged the responsible character of much student criticism of the Senate's procedures. She explained how she had herself introduced debate upon these matters among student leaders during the summer, and that many leaders shared her concern.

The Board acknowledged and shares the students' concern for the importance of sound fiscal management of student money. The student community should understand that the Board has no intention of abandoning its traditional policy of insisting that the expenditure of student activities fee monies be determined only by a student organization duly constituted for such purpose. If, however, the University is to continue to serve as tax-collector for the student government, then both the Board and the student community have a right to satisfactory disclosure of student government's financial dealings.

The Board, therefore, directed the President of the University and the President of ASG, jointly to undertake a thorough survey of the role of ASG in disbursing student monies. A report on findings and recommendations on this matter, will be presented to the Board at its next regular meeting. Failure by elected student leadership to resolve what appear to be valid criticisms by their constituents would, of course, require the Board to consider abandonment of the student activities fee as a university requirement.
