- 1. The minutes of the meeting of September 17, 1958, having been mailed out, were approved without being read.
- 2. THE BOARD VOTED to postpone election of a Vice Chairman and a Secretary. It was agreed that Mr. J. Ray Ryan would continue as Secretary in order that certain documents could be signed calling for the signature of the Board Secretary.

The completion of Special Committee assignments was postponed until later.

The President advised the Trustees of Mr. Shippee's inability to attend the November meeting. He also advised the Trustees of Mr. Shippee's reluctance to continue on the Board. THE BOARD VOTED unanimously to request the President to convey to Mr. Shippee the appreciation of the Trustees for his excellent service as a Trustee and as Chairman of the Board, and to indicate to Mr. Shippee the

realization of the Trustees of the many demands on his time, in addition to the time and energy he has devoted to the affairs of the University. The Trustees expressed the hope that Mr. Shippee would continue to serve on the Board, at least through the current academic year.

3. In accordance with the Board action of February 19, 1958, the matter of the President's salary was to be determined at the November meeting.

Included as a special item for consideration was the matter of an increase in student fees (not tuition) in accordance with the report of Mr. L. C. Riccio, University Comptroller.
